

RESOLUTION 03-20

**A RESOLUTION SETTING THE COMPENSATION OF THE  
ELECTED OFFICIALS OF THE TOWNSHIP OF BELVIDERE  
FOR THE TERM BEGINNING ON MAY 17, 2021  
BELVIDERE TOWNSHIP, BOONE COUNTY, ILLINOIS**

WHEREAS, pursuant to 60 ILCS 1/65-20, the compensation of Township officers shall be set by the Township Board at least 180 days before the beginning of the terms of office; and

WHEREAS, according to 60 ILCS 1/65-20, the compensation for the Road District Treasurer shall be fixed by the Township Board and shall not be less than \$100 nor more than \$1,000 per year; and

WHEREAS, pursuant to 605 ILCS 5/6-207, the compensation of the Highway Commissioner shall be fixed by the Township Board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties; and

WHEREAS, pursuant to 35 ILCS 200/2-70, the compensation of the Township Assessor and Collector shall be set by the Township Board at the same time the Board sets the compensation of its Township Supervisor.

NOW, THEREFORE, BE IT RESOLVED by the Supervisor and Board of Trustees of the Township of Belvidere, Boone County, Illinois as follows:

**SECTION ONE:** Salaries. The salaries for the offices of Township Supervisor, Road District Treasurer, Township Clerk, Trustees and Highway Commissioner are hereby set as follows effective the third Monday in May of each year:

A. For the period from May 17, 2021 – March 31, 2022:

**SECTION TWO:** Assessor's Salary. The salary for the office of Township Assessor are hereby set as follows:

A. For the period beginning on the later of (I) January 1, 2022 or (II) the date on which the person duly elected to such office at the consolidated election in April of 2017 takes and subscribes the oath of office or affirmation prescribed by the Illinois Constitution before a person authorized to administer such oath or affirmation, and give any bond that may be required by law, and ending on December 31, 2022.

**SECTION THREE:** Additional Benefits. In addition to the compensation specified above, the following Township officers will receive the following benefits:

- A. TOWNSHIP SUPERVISOR: Health insurance benefits, with the Township paying 95% of the premium, and the Supervisor paying 5% of the premium. Participation in the Illinois Municipal Retirement Fund, Life insurance.
- B. HIGHWAY COMMISSIONER: Health insurance benefits, with the Township paying 95% of the premium, and the Highway Commissioner paying 5% of the premium. Participation in the Illinois Municipal Retirement Fund. Life insurance. The Highway Commissioner will also have a Township vehicle for use for Road District purposes and nominal personal use.
- C. ASSESSOR: Health insurance benefits, with the Township paying 95% of the premium and the Assessor paying 5% of the premium. Participation in the Illinois Municipal Retirement Fund. Life insurance.


**SECTION FOUR:** Expense reimbursement. All elected officials will be reimbursed for all expenses incurred in the performance of their duties, including reasonable mileage, meals and registration expense for extra meetings, educational meetings, state meetings or any other board approved meeting/conventions related to their duties, which shall not be considered compensation for tax purposes.

**SECTION FIVE:** Severability. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or enforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.




**SECTION SEVEN:** This Resolution shall be in full force and effect from and after its passage and approval as provided by law.




