## MINUTES

**Call to Order/Roll Call** ~~ Supervisor Bill Robertson called the meeting to order at 5:00 pm. The pledges to the Flag were said and roll call taken with the following Board Members present Trustees Grover, O'Malley, Turner, Culvey and Supervisor Robertson, also present Clerk Schabacker, Assessor St. Angel and Hwy Commissioner Dixon. We have a quorum to do business.

Public Input ~~ no public comment requests submitted by the public.

**Discussion and Potential Action on Approval of Prior Meeting's Minutes** ~~A motion was made by Trustee Culvey to approve the minutes from the last regular township board meeting on May 10, 2022. The motion was 2<sup>nd</sup> by Trustee Turner and passed with Trustees Grover, O'Malley, Turner, Culvey and Supervisor Robertson indicating aye on a voice vote.

Discussion and Potential Action on Transfers ~~ there are no transfers.

### Reports

**Supervisors Report** ~~ Supervisor Robertson recognized the Executive Director of the BCCOA Kelly Hillan and Darrel Davis the President of the BCCOA.

**BCCOA Report** ~~Ms. Hillan discussed the BCCOA Strategic Plan and handed out a list of their goals to the Board and how they plan on reaching those goals. Ms. Hillan also thanked the Board for their contributions to the center. Mr. Davis spoke about the golf outing and how successful it was. This was accomplished with a lot of volunteer's and sponsors. The meeting focused on the new budget for 2023. The next full Board Meeting will be on June 20<sup>th</sup>. **Trustee Turner**, (Community Building Complex & Senior Trustee Duties) nothing at this time. **Trustee Culvey**, (Building Maintenance & Twp. Public Safety Coordinator) the sign out front has been fixed.

**Legal** ~~ there is no legal business to discuss at tonight's meeting.

New Business ~~ Discussion and Potential Action Acceptance of Clerk's Resignation. Trustee O'Malley made a motion to accept Clerk Schabacker's Resignation effective May 31, 2022. The motion was 2<sup>nd</sup> by Trustee Turner and passed with five ayes no nays on a roll call vote. Discussion and Potential Action on Appointment of Clerk, Supervisor Robertson asked for a motion to appoint Michelle Dixon Clerk effective June 1, 2022. Trustee O'Malley made a motion to appoint Michelle Dixon Clerk effective June 1, 2022. The motion was 2<sup>nd</sup> by Supervisor Robertson. Before a roll call vote was taken Clerk Schabacker said that Michelle came into her office and they discussed Michelle's office experience. Michelle currently does Board Minutes for an organization she is affiliated with. She also does office work and payroll for a church. I personally feel she is very qualified to do the job of Belvidere Township Clerk. Trustee Culvey voiced concerns about a husband and wife working at the Township together and that the position was not advertized. Trustee O'Malley stated at the County level the County Board Chairman appoints people to positions and they don't always advertize those positions. Trustee Grover read a Township Resolution/Policy #88.4 dated 1988. It states that members of the same immediate family cannot be employed at the Township. Supervisor Robertson stated that she will not be an employee she will be acting as an elected official. Trustee Culvey stated they looked up nepotism. Trustee Turner stated that he wasn't a fan of the husband and wife combo and didn't want to rush it. He wanted to be transparent about the whole thing. Supervisor Robertson met with Julie Bliss Boone County Clerk and together they called the State Board of Elections. The State Board of Election stated that there is no conflict of interest, it is allowable. Supervisor Robertson called for a vote. Trustee Grover abstained from voting. Trustee O'Malley voice aye, Trustee Turner voiced nay, Trustee Culvey voiced nay, Supervisor Robertson voiced aye. There being two ayes two nay and one abstention Clerk Schabacker voiced aye. The Clerk is only allowed to vote when there is a tie vote to fill a vacant elected position on the Township Board. Motion to appoint Michelle Dixon to the position of Belvidere Township Clerk passed with three ayes two nays and one abstention effective June 1, 2022.

**Discussion and Potential Action on Patrick J. Murphy Scholarship,** after discussion by the Board, Culvey made a motion to sign a one year contract with the YMCA for \$5,000. The motion was 2<sup>nd</sup> by Trustee Turner and passed with five ayes no nays with Trustee Grover, O'Malley, Turner, Culvey and Supervisor Robertson voicing aye on a roll call vote.

Trustee O'Malley made a motion to pay the town bills the motion was 2<sup>nd</sup> by Supervisor Robertson and passed with Trustees Grover, O'Malley, Turner, Culvey and Supervisor Robertson indicating aye on a roll call vote.

**Adjournment** ~~ a motion was made by Trustee O'Malley to adjourn the meeting at 5:26 pm, 2<sup>nd</sup> by Supervisor Robertson. The motion passed with Trustees Grover, O'Malley, Turner, Culvey and Supervisor Robertson indicating aye on a voice vote.
