Highway Commissioner's Report ~~ There have been issues with a couple candidates placing their campaign signs in the right-of-way. We ran three ads in the Boone County Shopper and posted on the township website to educate all about the sign rules, as far as keeping them out of the right-of-way. It was extra difficult this year with the primary being moved to June which conflicts with the ditch mowing schedule. Also, there was a letter drafted and delivered to homeowner's with signs in their yards, explaining the guidelines / liability, etc. We will be putting in six culverts in the next couple of weeks which will require extra manpower as closing the roads will be necessary.

Assessor's Report ~~ Finishing up evaluations in the next couple weeks and have a July 15, 2022 deadline with the county. Also, currently checking on farm land and making sure it is still being used as such.

Clerk's Report ~~ Verified that all received the agenda email from the new clerk email address.

Trustee's Report ~~ **Trustee O'Malley**, (Growth Dimensions &Twp/County Liaison) General Mills announced that they will be expanding with a new building. **Trustee Grover**, (Boone County Council on Aging & Twp/City Counsel Liaison) There has been delays in the meetings with cancellation emails being sent out to members. Will report when the board meeting finally happens. The full board meeting has been moved to July, as of right now, and the finance committee meeting has been moved twice.
