Discussion and Potential Action on Approval of Prior Meeting's Minutes ~~A motion was made by Trustee O'Malley to approve the minutes from the last regular township board meeting on June 28, 2022. Supervisors Report ~~ Had to get a new cell phone and am having a problem getting all info transferred over. Please call if an email goes unanswered.

Highway Commissioner's Report ~~ Olson Road shouldering will be Thursday (7/14). We are installing a new culvert on Beloit Road north of Spring Creek on Wednesday. Mowing will begin, again, the last week of July. We sprayed around all the guardrails to keep them visible. The County is having a problem getting the striping paint so Countryman will come in next week to get the yellow line, using the thermal method, done on Olson.

Assessor's Report ~~ Finalized the 2022 valuations. We are up township-wide by 3.3%. Residential increased 4-1/2%, commercial increased about 1%, and industrial increased 3%. Starting the process of switching over to a new software. Training is required for that. A question was raised by Trustee Culvey about how the increases are calculated. Assessor St. Angel explained that real estate sales and State of IL guidelines are used to calculate changes in valuations.
