The new truck came and was taken to get the service box installed. We are hoping to get it back next week. Be-Ver-Vue subdivision was re-paved. Mallard Point was paved and Youssi did pay for it. We have not accepted it yet because paper work from Youssi still needs to be filled out and sent to IDOT for approval. We may go back to mow some areas already done due to the blue flowers that grow and get woody and become hard on our equipment if not mowed down.

**Clerk's Report** ~~ Polled the board on when to put the discussion of elected officials salaries on the agenda. They decided to start the discussion in August.

**Trustee's Report** ~~ **Trustee O'Malley**, (Growth Dimensions & Twp/County Liaison) August 29<sup>th</sup> is the Growth Dimensions dinner at the Community Building. Also, Growth Dimensions is a finalist for a state award.
