MINUTES

Clerk Judy Schabacker called the meeting to order at 6:00pm at the Township building. She welcomed all in attendance to Belvidere Townships Annual Town Meeting. Clerk Schabacker then introduced all Township officials present for the meeting they are Supervisor Murphy, Trustees Bill Robertson, Kathy Grover, Bob Turner, Richard Nelson Highway Commissioner Rich Lee and Assessor Tami Torrance.

Clerk Schabacker asked for a motion to set the moderators salary. Bill Robertson made a motion to set the moderators salary at \$50 the motion was 2nd by Pat Murphy the motion passed with a positive show of hands by all in attendance.

With the salary set for the moderator Clerk Schabacker asked for nominations for a moderator to conduct business for the Annual Town Meeting. Pat Murphy made a motion to nominate Jim Hursh as moderator 2nd by Bill Robertson motion passed with all ayes no nays with a show of hands. With no other nominations Jim Hursh was sworn in by Clerk Schabacker as moderator.

Moderator Hursh asked for approval of the minutes of the last Annual Township Meeting held on April 16, 2013. Dan Snow made a motion to approve the minutes of the last Annual Town Meeting on April 16th 2013 the motion was 2nd by Steve Schabacker and passed with a positive show of hands indicating approval of the motion.

Moderator Hursh asked for the Supervisors report from Patrick Murphy. Mr. Murphy read from the General Assistance Annual report explaining how the program works and the fact that Belvidere Township does the program for the other 8 Townships in Boone County. Mr. Murphy stated that those receiving General Assistance are required to work off their debt if they are physically able to, 690 workfare hours were worked in this fiscal year. Moderator Hursh asked for a motion to accept the General Assistant Report as read by Supervisor Murphy. Dan Snow made a motion to accept the General Assistant Report as read, the motion was 2nd by Richard Lee and passed with a positive show of hands.

Moderator Hursh asked for the Annual Treasurer's Report from Clerk Schabacker. The Annual Treasurer's Report was read by Clerk Judy Schabacker. Clerk Schabacker also stated that these Funds are subject to audit and will also be published.
