MINUTES

Clerk Schabacker called the Belvidere Township Annual Town Meeting to order at 6:00 pm and asked all those in attendance to rise for the Pledge to the Flag. Clerk Schabacker thanked everyone in attendance for coming to the Annual Town Meeting. Handouts were available to everyone in attendance and included the agenda for tonight’s meeting, General Assistance Report, Supervisor’s Financial Statement, Minutes from last year’s Annual Town Meeting and Blue Placards for Belvidere Township registered voters to use to vote at tonight’s meeting. Township Executive Assistant Terri Bullard and Township Web Site Manager Cathy Flynn checked registered voters in from a listing provided by the County Clerk’s Office.

Clerk Schabacker asked for a motion to set the moderators salary. Pat Murphy made a motion to set the moderators salary at \$50.00 the motion was 2nd by George Crawford motion passed with a show of placards indicating that all those in attendance were in agreement with paying the moderator \$50.00.

With the salary set for the moderator Clerk Schabacker asked for nominations for a moderator to conduct business for the Annual Town Meeting. Dan Snow made a motion to nominate Clayton Stevens as moderator the motion was 2nd by Clayton Stevens. The clerk then asked if there were any other nominations for moderator at which time George Crawford nominated Jim Hursh for moderator that nomination was 2nd by Ron Brooks. There being no other nomination a vote was taken. With a show of placards Mr. Hursh was the clear choice to conduct the meeting as moderator. There being no other nominations Mr. Hursh was sworn in as moderator by Clerk Schabacker.

Moderator Hursh asked for approval of the minutes of the last Annual Township Meeting held on April 8, 2014. Dan Snow made a motion to approve the minutes of the last Annual Town Meeting of April 8, 2014 the motion was 2nd by Bill Robertson. The motion passed with a unanimous show of placards in agreement with approving the minutes of April 8, 2014.
