**MINUTES**

Clerk Judy Schabacker called the meeting to order at 6:00 pm at the Belvidere Township building. Welcome to the Belvidere Township Annual Town Meeting. Clerk Schabacker introduced all Township officials present they are Supervisor Robertson, Trustees Carlson, Grover, Nelson, Turner, and Assessor Tami Torrance.

Clerk Schabacker asked for a motion to set the moderators salary for tonight's Annual Town Meeting. Richard Nelson made a motion to set the moderators salary at \$50 the motion was 2<sup>nd</sup> by Steve Schabacker. The motion passed with a unanimous show of placards given out to all Belvidere Township registered voters in attendance.

With the salary set for the moderator Clerk Schabacker asked for nominations for a moderator to conduct business for tonight's Annual Town Meeting. Bill Robertson made a motion to nominate Bob Bowley as moderator 2<sup>nd</sup> by Dan Snow motion passed with a unanimous show of placards. Richard Nelson made a motion to approve the minutes from the last Annual Town Meeting on April 12, 2016 as presented. The motion was 2<sup>nd</sup> by Dan Snow and passed with a unanimous show of placards.

Moderator Bowley asked for the Supervisors report from Township Supervisor Bill Robertson. The General Assistance report for the year was read by Supervisor Robertson he gave some details on how the programs work.

Moderator Bowley asked for Acceptance of the 2016-2017 Supervisor's & Highway Commissioner's Annual Financial Reports. These reports are available at the door where you came in. Richard Nelson made a motion to accept the Supervisor's and Highway Commissioner's 2016-2017 Annual Financial Report's as presented. The motion was 2<sup>nd</sup> by Steve Schabacker and passed with a unanimous show of placards.

Moderator Bowley asked if there was any property that the Township wanted to declare to be Surplus Property for the purpose of donating to a Not-For-Profit Corporation. It was stated by Clerk Judy Schabacker that the Township had done that last year in 2016 but this year in 2017 there was no surplus property to donate.

Public Comments, Township resident Dan Snow wanted to thank the Township for allowing not-for-profit organizations use the township building meeting space at no cost.

Moderator Bowley asked for a motion to set the date for the next Annual Town Meeting for April 10, 2018 at 6:00 pm at the Township Building 8200 Fairgrounds Road Belvidere IL. A motion was made by Bill Robertson to set the date for the next Annual Town Meeting for April 10, 2018 at 6:00pm. The motion was 2<sup>nd</sup> by Richard Nelson and passed with a unanimous voice vote.

There being no other business of the Town Moderator Bowley asked for a motion to adjourn. Richard Nelson made a motion to adjourn the Annual Town Meeting at 6:14 pm. The motioned 2<sup>nd</sup> by Bob Turner and passed with all ayes no nays with a voice vote.
