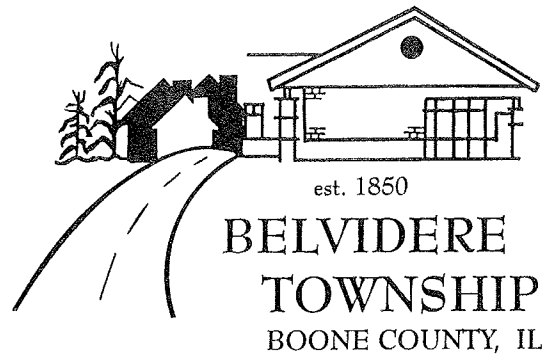

TOWNSHIP RECORDS DIRECTORY

ANY PERSON REQUESTING RECORDS OF BELVIDERE TOWNSHIP MAY MAKE SUCH A REQUEST IN WRITING AT ANY OF THE LOCATIONS LISTED BELOW OR ANOTHER METHOD WOULD BE BY MAILING A WRITTEN REQUEST. ALL REQUESTS MUST BE ADDRESSED TO THE PERSON DESIGNATED AT EACH LOCATION.

IN ACCORDANCE WITH P.A. 83-1013, THE TOWNSHIP MUST COMPLY WITH EACH WRITTEN REQUEST WITHIN FIVE (5) BUSINESS DAYS OR IN THE EVENT OF DENIAL OR THE REQUEST, SUCH DENIAL MUST ALSO BE MADE WITHIN FIVE WORKING DAYS. THE FIVE WORKING DAY LIMIT MAY BE EXTENDED UP TO TEN (10) IF THE REASON IS ONE AS LISTED IN THE P.A. 83-1013: WRITTEN NOTICE MUST BE GIVEN – GIVING THE REASON FOR THE EXTENSION WITHIN FIVE WORKING DAYS OF THE REQUEST.
