MINUTES

Call to Order/Roll Call ~ Supervisor Bernard O'Malley called the meeting to order at 5:00 pm. The pledges to the Flag were said and roll call taken with the following Board Members present Trustees Grover, Nelson, Turner, Snow and Supervisor O'Malley, also present Clerk Dixon and Hwy Commissioner Dixon. We have a quorum to do business.

Public Input ~ Linda Treu was present. No public comment requests submitted by the public.

Discussion and Potential Action on Approval of Prior Meeting's Minutes ~ A motion was made by Trustee Snow to approve the minutes from the last regular township board meeting on September 10, 2025. The motion was 2nd by Trustee Turner and passed with Trustees Grover, Nelson, Snow, Turner and Supervisor O'Malley indicating aye on a voice vote.

Reports

Supervisors Report ~ The elevator broke and the error codes are unfounded right now. We think it happened during the storms on August 16th. The elevator company is trying to move up the overhaul work on their schedule. The fire and sprinkler work is being done in October. The building was inspected by Boone County District 2 Fire. We received a bill from Ollmann Architects for the work they have done for the furnace last year. It was approx \$23,000. The Belvidere Cemetery will be receiving about \$240,000 on the next tax bill. This is about 5% more than last year. A small amount of this will go to Davis Cemetery and Orth Road Cemetery.

Highway Commissioner's Report ~ Doing a lot of brush cutting and will be starting the last round of mowing next week.

Assessor's Report ~ absent and no report submitted.

Clerk's Report ~ Nothing to report at this time

Trustee's Report ~ **Trustee Nelson**, (Community Building Complex) We are working on some preventative maintenance and creating a list of annual inspections to keep up on that maintenance. **Trustee Grover**, (Boone County Council on Aging) Harvest Moon fund raiser is October 11th 4-8pm. The center thanked all for supporting the name reveal, the ribbon cutting of the gazebo and the quilt raffle. They are now using both names when answering the phone until people get used to the change to "Senior Connections". October 14th from 1-3pm is the next Senior Food Distribution. Medicare Open Enrollment is October 15-December 7 and appointments are required. October 31st they are having a White Elephant Bingo from 1-3pm. Registration is required. Bring a wrapped gift to play. Trustee Snow asked about the
