MINUTES

Call to Order/Roll Call ~ Supervisor Bernard O'Malley called the meeting to order at 5:00 pm. The pledges to the Flag were said and roll call taken with the following Board Members present Trustees Turner, Snow and Supervisor O'Malley, also present Assessor St. Angel, Clerk Dixon and Hwy Commissioner Dixon. Trustee Nelson was absent. Trustee Arevalo arrived after the Clerk's report. We have a quorum to do business.

Public Input ~ No one was present from the public and no public comment requests were submitted.

Discussion and Potential Action on Approval of Prior Meeting's Minutes ~ A motion was made by Trustee Snow to approve the minutes from the last regular township board meeting on May 26, 2026. The motion was 2nd by Trustee Turner and passed with Trustees Turner, Snow and Supervisor O'Malley indicating aye on a voice vote.

Discussion and Potential Action on Transfers ~ there are no transfers.

Reports

Supervisors Report ~ The elevator is supposed to be fixed next week. The Heritage Days Parade is June 27 and we are signed up for one vehicle. Volunteers are needed for handing out pins and bracelets. Shred Day is June 20 from 9am-Noon; help is welcome. We have received two tax distribution checks so far. Insurance costs are going up about 19% next year.

Highway Commissioner's Report ~ We finished mowing last week. Edgewood Lane is close to finished but had a couple rain delays.

Assessor's Report ~ Still working on revaluations of new property and hope to be done with that by the end of the month. Did farm inspections the last couple of days.

Clerk's Report ~ Shared some Senior Connections events: Senior food distribution is June 12 from 1-3pm, Picnic in the Pavilion is June 17 from 11am-1pm (must RSVP), and Alzheimer's Association is leading an information session for caregivers and families on June 18 at 4pm.

Trustee's Report ~ **Trustee Nelson**, (Community Building Complex) Absent, no report. **Trustee Arevalo**, (Library/CASA) The library is putting in a pad for the Bookmobile. See new business. **Trustee Turner**, (Building Maintenance & Senior Trustee Duties) Nothing to report at this time. **Trustee Snow**, (Growth Dimensions & City Council/County Board Liaison) Nothing to report at this time.

Unfinished Business ~ **Discussion and Potential Action May Occur on the Following Items.** There is no unfinished business to discuss at tonight's meeting.

Legal ~ there is no legal business to discuss at tonight's meeting.

New Business ~ There is no new business to discuss at tonight's meeting, however, the Clerk brought up that she will be out of town at the end of July. The board decided to cancel the meeting on July 28th and change the August 11 meeting to August 4 due to the Fair and parking lot seal coating schedule. Now meetings in July will be July 14, August 4, and August 25.

After Trustee Arevalo's report, Trustee Turner asked if we can enter into an agreement with the library in the future; possibly a donation to the fuel of the bookmobile or other specific item. Trustee Arevalo and Supervisor O'Malley will look into this idea.

Discussion and Potential Action on Treasurer's Report and Approval of Bills ~

Trustee Arevalo made a motion to pay the town bills. The motion was 2nd by Trustee Snow and passed with Trustees Arevalo, Snow, Turner and Supervisor O'Malley indicating aye on a roll call vote.

Adjournment ~ a motion was made by Trustee Turner to adjourn the meeting at 5:22pm, 2nd by Trustee Snow. The motion passed with Trustees Turner, Arevalo, Snow and Supervisor O'Malley indicating aye on a voice vote.
